- (1) to assign Head of Control Service of the Prime Minister of the Republic of Armenia Sargis Grigoryan to conduct studies on the publicity of auctions, violations of procedures thereof, non-compliance with legislative acts and submit specific facts and proposals to Prime Minister of the Republic of Armenia Hovik Abrahamyan;
- (2) to assign Minister of Territorial Administration and Development Davit Lokyan and Chairperson of the State Committee of the Real Estate Cadastre adjunct to the Government of the Republic of Armenia Martin Sargsyan to submit taking into account all the facts and omissions presented a package of legislative amendments to the Staff of the Government of the Republic of Armenia within a 2-month period, which will once again be discussed with all the parties concerned and submitted to the National Assembly of the Republic of Armenia in the prescribed manner.
- 4. Representing risk assessment in the system of defence of the Republic of Armenia within the framework of "Government Defence Anti-Corruption Index 2015" global study:
  - representing the status of the action plan aimed at building integrity (good faith) and implemented in the Ministry of Defence of the Republic of Armenia within the framework of co-operation with the North-Atlantic Treaty Organisation

- (3) suggest to Chairperson of the Commission on Ethics of High-Ranking Officials of Republic of Armenia Siranush Sahakyan to submit, within a 2-month period, to the Staff of the Government of the Republic of Armenia proposals for new mechanisms for declaration and inclusion of new target groups.
